Summary

Consisting of correspondence, land and legal papers, and photographs documenting the lives of four generations of this York County family; including such materials as lease agreements signed by Catawba tribal representatives, commissioners reports, minutes of meetings of Indian landholders, and correspondence reflecting Indian affairs along the North Carolina-South Carolina boundary; and letters, 1810-1827, from James Moore, onetime resident of York District who removed to the old southwest and eventually settled near Natchez, first working as an overseer but later owning a plantation.

Includes Moore's letters to his brother-in-law, David Hutchison, discussing military problems facing planters in the Mississippi delta during the War of 1812 and comment re the difference in agricultural prospects between Mississippi and South Carolina; correspondence and legal documents reflecting the mercantile and banking interests and investments of Hiram Hutchison (ca. 1790-1856), son of David Hutchison, including letters, 1853-1854, between Hiram Hutchison, John L. Manning, and James H. Thornwell re the establishment of a scholarship at South Carolina College.

Also includes materials re the settlement of the estate of Hiram Hutchison and the marking of his grave at Greenwood Cemetery, New York; correspondence and miscellaneous documents re the work of Adolphus Eugene Hutchison (1827- 1905) with the Indian Land Chronicle, a York County newspaper, and the establishment in 1880 of the Rock Hill Cotton Factory, the state's first steam-powered cotton mill, which A.E. Hutchison served as president; and World War I letters from Hiram Hutchison (1895-1950) written from Camp Sevier, Ft. Sill, Ft. Bliss, and various locations in France and England, relating details of his military service in the 118th Infantry, his wounding and hospitalization, and return to South Carolina in 1919.

- ALS, 21 June 1811, Thos. McNeal, to D.H. (sending his and Dr. Henderson's receipts by Samuel Polk and stating--"My family and Sister and family is in tolerable health").
- ALS, 6 Aug. 1811, Natchez, James Moore, to D.H., York Dist. (reporting that he was living within nine miles of Natchez and overseeing for Eliz. White at \$350--"But I have made an Excellent Crop, & Expect to Stay another year if I can get good wages though I live a very

lonesome life & a very Disagreeable one," want of money compelled him to work as an overseer, enjoying good health, expecting a "Sickly Season" because of the Mississippi's high water--"it has overflowed all the Land for 20 or 30 Miles Back on t[he] other side of the River & Ruined all the crops of cotton on that side," hoping to return to S.C.--"But I am not satisfied nor wont be untill I get Back to you all & my native Country. That will never be untill I get Money Enough to put all my friends in a good humour I Dont want to meat them with my finger in my mouth," and inquiring re William Moore and his debt).

- ALS, 1 Dec. 1811, Natchez, James Moore, to D.H., York Dist. (re his dislike for the country--"I do not like people Nor their principles for they are the most dissapated characters on Earth though some of them are very Rich their has Bean above twenty in Jail here at one time for Murdering horse Stealing & none hang'd," and inquiring re William).
- ALS, 26 Jan. 1812, Natchez, James Moore, to D.H., York Dist. (acknowledging receipt of his letter and the welcome news of his marriage, expressing pleasure that he collected some money from William and hoping that he would get more, disputing a statement of William's re money, commenting on the number of marriages, and observing--"if they keep on a few years Longer that country will become a town," and his intention to pay his debts).
- ADS, 26 Mar. 1812 ("A Schedule of all the property Belonging to Joseph Moore").
- ALS, 28 Mar. 1812, Natchez, James Moore, to D.H. (stating that he was at James McIntosh's within three miles of Natchez and earning \$400.00 per year, commenting on news of acquaintances in York Dist., re the lax Sunday habits of the people in Mississippi, and reporting that he had seen Dr. Cook).
- ALS, 26 July 1812, Natchez, James Moore, to D.H., York Dist. (reporting they had heard of the war "which I fear will be an unhappy thing for our Country I stood my Draft yesterday and came off Clear," discussing the ties between England and many inhabitants of the region and advising that many would assist the British if they landed at New Orleans, rumors of a Negro insurrection, guns and powder taken from them, stating--"the heads of the plot are in separate confinement," still living with and working for James McIntosh who "is one of the Most agreeable men I have Ever Seen in this country," planning to work two plantations next season, and complaining that Dr. Cook had wronged him by "trad[ing] my note to an apothecary for the full value").
- ADS, 1 Sept. 1812, York Dist. (bond--Robert and John Neely to David Hutchison).
- ALS, 26 Dec. 1812, Natchez, James Moore, to D.H., York Dist. (acknowledging his letter, regretting his defeat in an election for a house seat and commenting on the inferior people who most often won elections, re his relationship with James McIntosh and expecting to manage both plantations next season for \$600, stating--"it hurts my feelings to hear that my Father & Mother are so fast Declining with Old age," hoping to send some money home, his disappointment with William, and news of friends from home).
- ALS, 15 Apr. 1813, Natchez, James Moore, to D.H., York Dist. (relating war news, expressing relief that father "has quit Drinking to access and has made good crops and doing well," and discussing his business affairs in York Dist.).
- ALS, 11 July 1813, Natchez, James Moore, to D.H., York Dist. (explaining why he did not send money by Ardrey and reporting the death of David Cook who "Departed this life on the fourth of April last Shortly after taking a frolic and has left a widow to Deplore his Loss").
- ALS, 15 Aug. 1813, Natchez, James Moore, to D.H., York Dist. (re debts to people in York Dist. and mentioning friendship he had probably lost by his failure to honor obligations, cotton crop in jeopardy--"Cotton Crops have look[e]d very well here untill about three weeks back it has taken they Rot and as fast as the pods come to perfection they are Blasted and produce nothing," corn crops good, noting several sugar plantations inundated by flooding of the Mississippi River, large numbers of livestock lost, and preparations for war with the Creek Indians).
- ALS, 20 July 1814, Natchez, James Moore, to D.H., York Dist. (planning to return to South Carolina "at the End of this year," complaining about the intense heat and lack of rain which

destroyed crops, and referring to his parents and associates in York Dist., including Robert Neely and Andrew Craig who apparently were indebted to David Hutchison).

- ALS, 28 Aug. 1814, Natchez, James Moore, to D.H., York Dist. (acknowledging receipt of his letter, mentioning plans to leave for S.C. and suggesting that the war might be a factor--"there is Every Reason to Suppose that this will be a troublesome place if the war Should continue there are a great many internal Enemys and it is Reported that the British have landed considerable force at or near pensacola, and the negroes will be much against this Country," planning to buy D.H. two mules when he left but expecting to pay a higher price due to the war, news of crops, mentioning the death of James Montgomery on the Sabine River--"he was shot Dead Some where near the Sabine River in the Spanish province," and David T. W. Cook living in Wilkinson--"I have been informed he dont drink so much as usual but takes it lightly and keeps a good...fiddle").
- ALS, 29 Aug. 1814, Natchez, James Moore, to D.H. (expecting to be home by Jan. 1815 and mentioning other acquaintances from York Dist.).
- ALS, 8 Oct. 1814, Natchez, James Moore, to D.H. (reporting that he avoided the draft by paying \$50 for a substitute, mentioning the mules that he had purchased for D.H. at \$100 each, re reports of British intentions in La., and reporting his visit with D.H.'s friend Cook).
- ALS, 20 Nov. 1814, Natchez, James Moore, to D.H., York Dist. (re plans for returning home and the likelihood that McIntosh would not be able to pay him for the present crop, mentioning his evening with Cook--"he keeps a fiddle and a set of fools about him he plays and they Dance and Sing and the[y] all take a sip at the Bottle--its Disgusting, and all genteel people Shun Such company," and suggesting that Cook practiced medicine only because there was not another physician available).
- ADS, 12 Mar. 1815, York Dist. (resurvey of tract of land containing 202 1/4 acres that formerly belonged to Robert Neely).
- ALS, 13 Mar. 1815, Natchez, James Moore, to D.H., York Dist. (re his employment situation--"I have the chance of working hands on equal Shares another year besides geting a handsome Sallery for my own Services but have not made a final contract," instructing D.H. re his family's affairs, re bringing mules to S.C., and cotton selling for \$27 in Natchez and \$30 in New Orleans).
- ADS, 4 Dec. 1815 (bond--Hiram Hutchison to William Armstrong and Robert Neely).
- MS, 6 Mar. 1816 (affidavit re ownership of land).
- ADS, 9 May 1816 (statement of agents "Lagaly appointed to act for the Cataba nation" affirming D.H.'s lease of his land).
- ALS, 8 Sept. 1816, Natchez, James Moore, to D.H. (commenting on the long cessation of correspondence from D.H., cotton selling in New Orleans for \$100 and slaves also bringing good prices--"I seen a negro sell for two thousand and five Dollars on a credit of six months--he was a rough carpenter--good field hands from \$650 to 800 Dollars--and it is supposed a hand will pay for himself nearly in one year by making cotton," re the production of his hands and comparing with Carolina, advising--"if I had negroes enough to work a plantation I should wish it to be in this Territory on acct of the Goodness of the Soil and convenience of Market, and as for health its as healthy as Carolina," wanting letters from his family, and discussing brother William's situation).
- MS, 18 Oct. 1816 ("A List of articles Sold at Vendue by Polly Wilson").
- ALS, 10 Nov. 1816, Natchez, James Moore, to D.H., York Dist. (acknowledging his letter of 8 Oct. with news that his father and brother William sold the plantation for \$8/acre. discussing family business affairs, and noting--"I expect to begin to work on my own Land this winter if I can purchase a likely negro fellow which is my intention and probably two").
- ALS, 29 Jan. 1817, Natchez, James Moore, to D.H., York Dist. (re his business affairs with brother William and others in S.C., and stating--"I am Geting six hundred dollars this year for

Just riding over a plantation and get three hundred for two negroes without any expence but am Determin'd to quit the business this fall and return to York").

- ALS, 4 Feb. 1817, Natchez, James Moore, to D.H. (discussing a document that D.H. wanted to conduct J.M.'s business affairs, and regretting his father's ill health and the possibility of not seeing him again).
- ALS, 27 Feb. 1817, Natchez, James Moore, to William Moore, York Dist. (re letters received and sent, willing to send full power of attorney to D.H., planning to quit the overseeing business and come home in the fall, selling last year's crop--"160 Bales which I Sold for \$25 Dollars amounting to the round Sum of \$14,650.75--which would buy half the cotton in the indian Land," and urging him to sell all his land and come to the territory).
- ADS, 25 June 1817 (power of attorney--James Moore to D.H.--giving Hutchison authority to sell his Indian lands in York Dist.).
- ALS, 4 Aug. 1817, Natchez, James Moore, to D.H., York Dist. (acknowledging his letter informing him of his father's death and his intention to return to S.C. to discharge family business, and mentioning the possibility of sister Peggy living with Aunt Harris to "take care of her in her old age").
- 2 ADsS, 12 Aug. 1817, York Dist. (lease and release of lands between D.H. and the Catawba Indians).
- ALS, 28 Oct. 1817, Natchez, James Moore, to D.H., York Dist. (planning to leave for S.C. at Christmas, discussing business affairs that he wished D.H. to settle, the yellow fever spreading from New Orleans to the Ohio River, five to ten dying daily in Natchez).
- ALS, 8 Aug. 1818, Natchez, James Moore, to D.H., York Dist. (business affairs in S.C. and sending him the Mississippi State Gazette).
- ALS, 8 Oct. 1818, Natchez, James Moore, to D.H., York Dist. (acknowledging his letter, reporting an uncommonly dry season--"Still I think there will be corn Sufficient to answer every purpose, and the cotton crops are good, when the rot has not affected it, which appears to be quite light in some places," re business affairs, stating--"all the money I can raise here I expect to give for negroes as soon as I receive it--in order to make cotton while the price is favourable," and possibility of postponing his return to S.C. until after another crop).
- ALS, 23 Oct. 1818, Natchez, James Moore, to William Moore, York Dist. (crop news, re an offer of \$10/acre for his land, stating that his reason for allowing D.H. to keep his money was that "I consider him a safe hand," inviting sister Peggy to come for a visit--"I will give her a negro girl as a compliment for her visit," pointing out to William the opportunities in the West that were not available in S.C., and reluctant to leave for S.C. until after his crop was finished).
- ALS, 27 Jan. 1819, Natchez, James Moore, to D.H., York Dist. (re his pleasure upon the arrival of Hiram Hutchison for a visit, his return from a visit to New Orleans "in good health and Spirits & to my satisfaction does not think so highly of the place as many fools do," and instructing him to pay Isaac Harris \$100.00).
- ALS, 4 Feb. 1819, Natchez, James Moore, to D.H., York Dist. (stating that he was in the same business and engaged for the year, re his purchase of three Negroes--a husband and wife and ten-year-old boy--for \$1,850 "which sweeps my cash and leaves me without one cent to buy tobacco," looking for a spot "to make a permanent settlement," and inquiring about money due him).
- ALS, 22 Mar. 1819, Natchez, James Moore, to D.H., York Dist. (re the dissolution of the partnership with Mr. Williamson, living on his own place and needing funds to purchase horses, plows, and provisions, falling cotton prices, and other business).
- MS, 1819 (receipt--James Moore in account with William Hoag).
- ALS, 5 Jan. 1820, YOrk, H[iram] H[utchison], to D.H., Indian Land (soliciting support for Albert Allison who was a candidate for the Clerk's office).

- ALS, 11 May 1820, Charleston, H.H., to D.H., York Dist. (preparing to sail for N.Y., re his business affairs, selling cotton, Cordy Pierce riding his horse to Newberry, and giving an account of purchases and sales).
- ALS, 15 May 1820, Charleston, H.H., to D.H., York Dist. (business matters, sale of D.H.'s 9 bales, and his arrangement with Robert Latta).
- ALS, 17 May 1820, Off the Bar of Charleston, H.H., to D.H., York Dist. (listing merchants with whom he dealt).
- ALS, 22 May 1820, New York, H.H., to D.H., Yorkville (re his pleasant voyage, leaving for Philadelphia to purchase dry goods, and establishing his business in Newberry).
- ALS, 23 May 1820, Natchez, James Moore, to D.H., York Dist. (re his marriage to a fourteen-year-old woman, instructing him to give \$500 to his wife's cousin who was traveling to S.C., and other business).
- ALS, ca. 24 May 1820, H.H., to D.H., Nation Ford, York (giving an account of sale of 18 bales of cotton, stating--"Business has been brisker with me than I calculated on," requesting him to send any money to Charleston to Thos. Fleming "Subject to my order...it may be the...means of me establishing my credit with my Friends in the Mercantile business--which will be of some importance").
- ALS, 25 May 1820, Natchez, James Moore, to D.H., York Dist. (instructing him re his business affairs in York Dist.).
- ALS, 10 Aug. 1820, Newberry, H.H., to D.H., Nation Ford (listing goods that he was shipping).
- ALS, 20 Oct. 1820, Newberry, H.H., to D.H., York (including a bill for blankets purchased).
- ALS, 16 Dec. 1820, Newberry, H.H., to D.H., Pine Hill P.O., York Dist. (re a disagreement between them over the purchase of blankets, etc., explaining his position and actions, and responding to his father's statement "that I can calculate profit & Loss better than Right & Rong").
- ALS, 21 Jan. 1821, Newberry, H.H., to D.H., Pine Hill P.O. (re his purchasing of goods on credit and inquiring--"If you can procure any money out of any of those Estates by March it will enable me to lay in goods in the Spring to some advantage").
- ALS, 30 July 1821, W[illia]m Barron, to John Hart (re the Rev. [Eleazar] Harris' interest in acquiring "the studdy house at the old church for his own uce").
- ALS, 8 Apr. 1822, Natchez, James Moore, to D.H., York Dist. (re the birth of his daughter, stating that he had been offered an overseer's job at \$12,000 pr year "but have declined in consequence of having a family and plantation of my own," working "Eight prime negroes" and 35 acres of cotton with 30 more to plant, paying a white man \$250 pr year to supervise his work force, reporting that he sold land at Bayou Sarah, and regretting to learn of William's drinking and separation from his wife).
- ADS, 13 July 1822, Montgomery County, Ala. (power of attorney--Randolph C. Harris to D.H.).
- ALS, 26 Sept. 1822, Newberry, H.H., to D.H. (business not particularly brisk and cash scarce and sending him a few articles).
- MS, 11 Jan. 1823 (Joseph Moore in account with George Graham, 1789-1811).
- ALS, 25 Jan. 1823, Montgomery County, Ala., Randolph C. Harris, to D.H., York Dist. (instructing him re his business affairs).
- ALS, 20 Feb. 1823, Natchez, James Moore, to D.H., York Dist. (re business affairs and family news).
- ALS, 10 Dec. 1825, Columbia, H.H., to D.H., York Dist. (enclosing his father's bank account, re items that were unavailable, and other business matters).
- ALS, 2 Feb. 1826, Newberry, H.H., to D.H., Yorkville (reporting the sale of his remaining Goodson land, concerned about his obligations and hoping that his father "will be able to do something considerable in raising funds for me," and leaving soon for Charleston).

- ALS, 7 Feb. 1826, Columbia, Th. J. Roach, to D.H., Ebenezer P.O. (requesting that he collect some notes due his sister).
- ALS, 22 Feb. 1826, Columbia, H.H., to D.H., Indian Land (low prices and doubting that prices could rise--"there is a heavy stock in Augusta and also at this place and a large proportion in the country," advising that he would sell at the present price, planning to deliver all his goods to R. McCullough & Co. in Newberry in Apr., hoping to take stock in Newberry in Apr. and Columbia in May, and concerned about payments due in Apr.).
- MS, 27 June 1826 ("lines copied...to be used at the celebration of Independence at York").
- ALS, 26 Aug. 1826, Troy, Tenn., John Hutchinson, to D.H., York C.H. (re his travels, stating that cotton grew well, his Negroes hired out for the year, requesting that he advise John Baxter of the opportunities available, and family news).
- MS, 12 Sept. 1826 (receipt for a note to be collected).
- ALS, 17 Jan. 1827, Columbia, H.H., to D.H., York Dist. (re his father's cotton that he was holding, and noting that Mr. [William E.] White seemed displeased over some shoes that he bought from H.H. at Newberry).
- ALS, 1 Feb. 1827, Columbia, H.H., to D.H., York Dist. (re his father's concern about the shoes and discussing his preference for settling the account).
- ALS, 1 Feb. 1827, Columbia, H.H., to Wm. E. White, York Dist. (re the disagreement over the shoes that White apparently rejected, explaining his father's concern and his desire that the matter be settled "in order that his mind may be more at ease," and advising--"Were it not on his account the business would be settled in court, as I do know that I have not exceeded your directions about the shoes").
